

RELEASE AND INDEMNITY AGREEMENT

The undersigned hereby acknowledges that he/she has knowingly and willingly entered into this Release and Indemnity Agreement with **Brazos Trails Cowboy Church of Parker County, Inc.** (hereinafter referred to as "BTCC").

The undersigned acknowledges and understands that there is no warranty, either express or implied, as to the condition of the properties comprising BTCC that are owned or leased by BTCC located in Parker County, Texas. This includes, but is not limited to, any roads, trails, buildings, gates, arenas, or other improvements located or situated thereon. I have been warned, or by virtue of my execution of this document have been warned, that dangerous conditions, risks and hazards do in all likelihood exist. I acknowledge my presence and activities conducted by me, singularly or in concert with others on BTCC, exposes both me and my property to dangerous conditions, risks, and hazards, including, but not limited to, poisonous snakes, insects and spiders, cactus, buildings, barns, corrals, pens, flying objects, fences and other improvements, whether or not erected by BTCC, which may not be designed to accommodate the activities which are sought be conducted. I also acknowledge that there may be erosion and general conditions of the land, both on and off the roadways, paths, or otherwise, that create rough, hazardous and dangerous driving, riding and walking conditions, and that the utilization of the property in all likelihood will expose me to both wild and domestic animals that may be diseased or potentially dangerous, as well as deep water, and vehicles also using the property. I hereby represent that I am aware of these facts and I expressly assume all such dangers, risks, and hazards associated with them upon behalf of myself and each and every member of my family, and I agree to hold BTCC, harmless from these conditions whether or not caused by the negligence of BTCC.

In consideration for permission to enter the premises, I hereby release and agree to protect, indemnify and hold harmless BTCC and its members, volunteers, agents, servants, employees, family members and assigns from and against any and all claims, demands, causes of action and damages including attorney's fees, that may arise resulting from any accident, incident or occurrence arising out of, incidental to or any way resulting from the use of the premises in question and any improvements located thereon, whether or not such may be caused by the negligence of BTCC or any of their members, volunteers, agents, servants, representatives, employees, successors or assigns or by reason of the conditions or arising from any activities occurring thereon, whether or not caused by the negligence of BTCC, or its members, volunteers, servants, and employees.

As used in this Release and Indemnify Agreement, the terms I, my person, and myself, including minors in my care while on the premises. I agree to accompany any minor child at all times while on the premises in question to prevent and avoid any possible imposition of any claim of liability against BTCC.

Under Texas Law (Chapter 87, Civil Practice and Remedies Code), an equine professional is not liable for any injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities.

I give permission for my/my child's photo, which may be taken, to appear at BTCC and/or promotional publications. I give permission for my/my child's photo and/or video, which may be taken, to appear on the church website.

By signing this Release I agree to furnish my coggins number for every horse under my ownership on the BTCC property.
